This event has limited vendor opportunities! Vendors will be provided with a 6' table, table cloth, and one chair. Additional space may be available for an additional charge. Electricity is available and free of charge if indicated on the Application Form. **Table Fees are \$30.00**

SET UP

Set up is from 2:00-4:00pm, NO EARLY ARRIVALS TO UNLOAD. On the day of the event, you must park across the street at the Highland Elementary School parking lot AFTER unloading your vehicle.

NO UNAUTHORIZED PRODUCT SALES

When filling out your Vendor Application Form you are asked what items you sell. Please bring only items listed on your Application. You may be asked to remove items that have not been approved.

SWAG BAGS

Swag bags (75) are distributed to Ladies' Night attendees. You are welcome to add a coupon, flyer, promotional item, or product sample, although not required. Additions should be turned into the HDDA four days prior to the event. Please email Cathy at highlanddda.events@gmail.com for details.
