Design

Promotions

The committee decided to keep the event to one day with the possibility of other events such as the Pancake Breakfast and the Fun Run to take place on the following Sunday.

Pilchowski suggested that the DDA should issue personal invitations to the residents in the neighborhoods in and around the Highland Station district for all of our planned events.

Mecklenborg suggested that we might highlight a specific street be chosen for each concert and that we provide something for them such as a free hotdog dinner.

It was suggested that the Promotion Committee should meet with those involved with the Milford concerts to coordinate our events.

Colbeck reminded the Board that our year-end evaluation by MSOC is scheduled to take place on April 7, 2009. He also reminded them that MSOC and the National Trust will be hosting Main Street 101 classes on February 4th and 5th in Pontiac.
